- 1) The NOC is valid for the academic year 2016-17.
- 2) The Society / Institute shall abide by all the rules and regulations in force in Delhi by the Govt. of India, Govt. of NCT of Delhi, other local authorities and the affiliating University.
- 3) The Society / Institute should install latest software in Computer Centre.
- 4) **Building should be made disabled friendly. Ramps/Lifts may be installed.**
- 5) **Cubicles should be made for each faculty member.**
- 6) **Faculty should be encouraged for higher education i.e. Ph.D.**
- 7) **Salary should be as per norms of UGC.**
- 8) **Librarian should be appointed as per the norms of NET.**
- 9) **Computer should be available with all faculty members.**
- 10) **More standard books should be procured/purchased.**
- 11) **More lighting arrangement is required in class rooms in general and for Boards particularly.**
- 12) The institution / society shall follow the fee structure prescribed by the University / Govt. of NCT of Delhi (**State Fee Regulatory Committee**) and will not charge any unauthorized additional fee or any advance fee for the next session. It will also be ensured that security deposits of students and their original certificates are returned back in appropriate manner and within stipulated time. No extra fee shall be charged for the book bank facility.
- 13) If it comes to the knowledge of Govt. of NCT of Delhi that the NOC has obtained by giving any false or misleading information or by concealing or suppressing any material facts or information, the NOC granted shall be withdrawn/cancelled.
